- **** For **individual Junior Memberships**, at least **ONE parent must join as a Guardian Member**. This is for legal and Child Protection purposes, is essential for communications, and because the parent will know and use the key-code.
- Additionally, **the Club advises that all NON-PLAYING PARENTS and other ADULTS** (e.g. NANNY, GRANDPARENT) who will be accompanying children to the Club and using the key-code **must also join as Guardian Members** as it is essential that adults/parents who are often at the Club are "known" to/registered with the Club - whether just supervising their children or bringing them to coaching.

TERMS & CONDITIONS 2018

- **Playing-Members** of the FB&TC may play Tennis *and* Lawn Bowls (April - Oct/Nov.) *and* Boules (all year).
- **Social or Guardian Non-playing Members** are welcome to play Boules but *may not play on the tennis courts or bowling green except as the invited guest of a Playing Member and having paid the guest fee.*
- The Club grounds are open to Members to enjoy all year. During the season, play is permitted from 08:00-22:00
- **FB&TC Membership requires members to agree to abide by the Rules and Bylaws of the Club. A No-smoking and No-vaping Rule applies** at the Club, clubhouse and grounds, and **Dogs** must be held on a leash at all times and never allowed to run free at the Club. Members must sign in all guests/visitors/non-member family members immediately on arrival and must also pay the visitor fee for playing-guests before play commences. Generally accepted on-court and on-green etiquette also applies at the Club.
- **PHOTOGRAPHS** are often taken of Club events and may be shared with the FB&TC Membership, through a Club Newsletter, or used for publicity and flyers. **If you object** to yourself or your family being in such Club photos, **please inform us by sending a letter** to the FB&TC Secretary, so that your objection may be kept on file for quick reference.
- **The FB&TC now communicates with members primarily by e-mail.** Group e-mails are sent 'blind copy'/Bcc.
N.B. Please check that emails from falconclub@hotmail.co.uk are accepted by your INBOX and don't end up in JUNK/SPAM.
- **TENNIS COACHING 2018 – Young Members age 5 – 18 incl.**

MEMBERSHIP INFORMATION & VOTING

The Falcon Bowling and Tennis Club Limited is a company limited by its guarantee. This means that it does not have shares or shareholders; instead, it has members. Its day-to-day management is carried out by the directors, but by becoming a member you will be entitled to do the following things:

- to attend and vote* at general meetings. (Normally there will be one meeting per year, called the Annual General Meeting, or AGM, and members will be given at least two weeks' notice of the place and time of the meeting. The directors may also need to call other general meetings in exceptional circumstances.)
- to receive the annual accounts of the company
- to elect directors by voting* at the Annual General Meeting
- to vote* on any fundamental changes to the nature of the company, its name, its purposes or what happens to its profits.

VOTING RIGHTS - PLEASE NOTE * In accordance with the Memorandum & Articles of Association, *only full, Playing-Members who are aged 16-and-over and who have signed their own membership application form are entitled to vote.*

**Junior and Social or Guardian Non-playing Members may attend General Meetings but may not vote.*

**Members who joined on a part-payment or discounted membership in 2017 will only be eligible to vote at the 2018 AGM if they renew their membership with a full subscription on or before Saturday 17th March 2018.*

**Members who join on a part-payment or discounted membership later in 2018 will only be eligible to vote at any subsequent AGM or EGM if they renew their membership with a full subscription by 1 week before that meeting.*

You will not be entitled to receive any individual or other income from the Company. If the Company makes a profit this will be retained to help pay for the Company's activities in the following years. If the Company is wound up, any assets left after all its debts and liabilities have been settled will be distributed equally amongst its Full Members. The Constitution is made up of the Memorandum and the Articles and the Rules. The Memorandum sets out what the Company can do and why it exists and the Articles deal with the holding of meetings, the admission of members, the election of directors and other rules relating to the running of the Company. These are legal documents that are registered on the public records for the Company held at Companies House. They may also be inspected at the Company's **Registered Office**, 3 Falcon Gardens (Flat 4), Edinburgh, EH10 4AP, where you may also inspect the Rules made by the Company to date.

You will not be liable for any debts of the Company by becoming a member. You will not be liable if someone brings a legal case against the Company. This is because, like most other companies, it is a limited company, which means your liability as a member is limited. If the Company is wound up (which may happen, for example, if it cannot pay its debts) then you will have to pay *no more than £1* to the Company. This is the amount that you 'guarantee' or promise to pay the Company by becoming a member, as set out in Clause 5 of the Memorandum. Additionally, if you have paid a subscription to the Company there may not be enough funds left to return to you any of that subscription, even if the winding-up happens part-way through a membership year.

By signing this application form you are applying for membership of the Falcon Bowling and Tennis Club Limited, and agree, subject to the provisions of the Memorandum and Articles of Association of the Company and to the Rules, to pay to the Company an amount of up to £1 if the company is wound up while you are a member or for up to 12 months after you have left the Company. You also agree to pay any membership fee levied in accordance with the Company's Rules. Your membership will be for 12 months and may be renewed annually on full payment of the subscriptions determined by the Board of Directors or by any other method of payment approved by them.

NEW MEMBERS ARE WELCOME. All applications are subject to approval by the Board which shall be exercised in accordance with the Rules. As a condition of membership, all members shall be subject to the Rules, a copy of which can be viewed at the Registered Office.
